Dear Friend,

It is time to renew your membership in the Friends of Valley Falls for fiscal year July 1, 2016 to June 30, 2017. Your support is needed and very much appreciated.

We are well aware of the scenic value that Valley Falls Farm adds to our community, and we work hard to preserve this value. Your contribution to our Special Building Fund helps us keep the property maintained, visually attractive, and in a condition that enhances this beautiful area.

We are especially challenged by the Farm's *seven* buildings, which include a large stable and a historic 1840 farmhouse. These old buildings require constant upkeep. This fiscal year we continued the painting work on the interior of the stable, and culled through some of the old contents to determine which pieces should be preserved. Funded by a state grant, the Valley Falls Heritage Center will be established in the stable. The Center will provide information about the National Historic Register sites in the Valley Falls area, as well as information about Valley Falls Farm's history as a "gentleman's farm".

In 2014 we set up a committee structure in order to strengthen the organization. The committees are listed on the attached form. Your help is needed! Please let us know if you have a particular expertise or would like to assist with any one of the committees.
