#### **REPORT FROM THE BEEKEEPERS**

ost of the beehives at Valley Falls Farm survived the winter, but the rainy spring weather meant that the bees did not start producing honey until a bit later in 2020. The bees can tolerate the heat, but lack of rain ultimately means no nectar flow which also means less honey production. Allen Valli, Marcie Lavoie, and Tom Kaminski report that for the period of September 2019 through August of 2020 the six hives produced about 300 pounds of honey. # HERITAGE CENTER UPDATE

E ven under Covid circumstances, we've been able to make progress through the summer. Electrical work has been completed, including the new underground line to the stable and the track lighting to highlight displays. We've cleaned the outbuildings, sorted through their one hundred

years of stored "stuff", and culled out the items that tell the story of Valley Falls Farm. We are delighted with our finds, and are pleased to say that we are able to tell the story with ONLY the artifacts found on at the Farm, making it a truly local and authentic experience for visitors!

The final phase, organizing, cleaning, and labeling the artifacts, and setting up the displays, has begun. In keeping with our goal to use only on-site artifacts, we will "repurpose" old tables, barrels, and crates found on the Farm to show the vintage pieces. We have hired **Austin Bach** to manage this last project phase. Austin is a graduate of Maine

College of Art, with a major in graphic design, and a focus in woodcraft. We are pleased to have assistance from high school students **Jacey Letendre** (Glastonbury High School) and **Stefanie Schmelter** (Ellington High School), who are putting in time to meet their schools' community service requirements. ## THE BELL AT VALLEY FALLS



ur bell is not, as you might think, original to Valley Falls Farm. The bell was actually moved from the Springville Mill in Rockville sometime in the early 1960s by the Darico family. Bernice and Peter Darico, former owners of Valley Falls Farm, were avid bell collectors. They had a collection of about 250 bells that they occasionally put on display for public viewing, both at the Farm and at places like Rockville Library. The Darico family was also well connected to Rockville gentry, some members having been in their employ over the years. These connections enabled them to obtain the bell at a time when the purpose of mill bells had become outdated, and when mill manufacturing was in decline in Rockville.

The bell, cast by the Maneely Bell Foundry of Troy, New York, was probably installed in the Springville Mill tower in 1886 when

mill owners George Maxwell and George Sykes replaced the old wooden mill structure with a modern brick manufacturing facility, the imposing building we see today on West Main Street, now converted to apartments.

Mill bells played an integral role in the life of the mill workers of the late 1800s. They called workers to their shifts, and rang for wake up time, lunch time, and sleeping time. The Springville mill ceased operations in 1951, but its bell continues to ring and be heard by the visitors here at Valley Falls Farm.
